## Subject: - MINUTES OF THE PRE-BID MEETING REGARDING SUPPLY OF UNIFORM AND PPES AND FABRICATION OF AMBULANCES DATED 05-03-2025

Pre-Bid meeting of the Procurement Committee on the subject cited above was held under the Chairmanship of Additional Secretary RR&S Department, Khyber Pakhtunkhwa on 05-03-2025 at 1200 hours in the committee room of RR&S Department. The following attended the meeting: -

- 2. The Chair welcomed the participants followed by a brief introduction by all members/vendors of the meeting. After introduction, the Incharge Procurement Cell RR&SD formally initiated the proceedings.
- 3. The CEO of M/S Philanthrope requested to reduce the period of warranty for fabrication of ambulances from 2 year to 1 year. However, the committee did not agree.
- 4. The representative of M/S Collaborative Heavy Industry and other requested to remove clause (g) "Firm having its own manufacturing plant (OEM certificate and ESSI & EOBI and must provide details of local labor as proof)" from mandatory criteria for fabrication of ambulances and to shift in evaluation criteria. After threadbare discussion, the committee agreed for incorporation of clause (g) in the Evaluation Criteria.
- 5. The representative of M/S H.N Group and M/S Tradeline Corporation requested for clarification regarding samples. The committee briefed the forum that those firms who wants to apply for Uniform & PPEs shall submit 02 samples along with technical bid, the samples will be sent for Lab testing at the cost of bidder and the proceedings will be based on lab results. Moreover, the technical bids received without samples shall stand rejected straightaway.
- 6. The meeting ended with a vote of thanks from the chair.

## Revised Mandatory Criteria.

- a) The bidder(s) shall provide National Tax and STRN.
- b) The bidder should be on Active Taxpayers List (ATL) of FBR.
- c) Bidder(s) must provide an Affidavit on judicial stamp paper of Rs.500/- that bidder is not currently blacklisted by any Public/Private Sector Organization in Pakistan.
- d) The firm/bidder shall provide a conformity certificate on Judicial Stamp Paper that all the relevant documents regarding the past experience/ bank statement, annual audit reports and other required documents submitted in the bidding documents are genuine and correct.
- e) The bidder must submit an affidavit on judicial stamp paper agreeing to replace any supplied/install items found to be sub-standard or not in compliance with the specifications of the contract agreement, at their own expense.
- f) The bidder must certify on judicial stamp paper that they shall provide 02 years warranty after sales service alongwith spare-parts shall be free of cost.
- g) PEC Valid Registration Certificate in Category C-4 (ME-06) or higher.
- h) Standardization certificate for fiberglass by Govt. standardization committee.
- i) Bank Account Maintenance Certificate.

Note:. Those bidders who do not comply the eligibility/mandatory requirement will not be considered for further evaluation and will be declare Non-Responsive/Disqualify.
