4. Only technical bids will be opened on date of tender opening in the presence of interested bidders, while financial bids of technically qualified bidders will be opened on a date to be intimated later to qualifying firms.
5. Earnest money in the form of bank guarantee/cross cheques etc. will not be accepted.
6. The procuring entity may reject all bids or proposals at any time prior to the acceptance of a bid or proposal as per KPPRA Rules, 2014 47(ii).
7. All Federal & Provincial duties/taxes including Stamp Duty & DPR will be recoverable as per existing directives of the Government issued from time to time.
8. The tender documents which are incomplete, corrected, over written will be considered non responsive and will be rejected.
9. All the intending firms should provide samples on the date of tender opening for items at S.No.01 and S.No.05 Tender/technical bid will not be opened if the samples are not provided.
