The technical & financial bid be sealed in separate envelops with clear write up of Technical Bid and Financial Bid in bold eligible writing. Both technical and financial bids be enclosed in single envelop to be delivered in the office of Director Finance (Rescue-1122) Khyber Pakhtunkhwa.

- The approved Bidding Document will be provided upon request with the proof of Registration with Income Tax, Sale Tax and any other Registration if required by Provincial and Federal Government.
- 2. The entire Bids will be opened in the office of Director Finance, near Press Club opposite Cantt: Railway Station Peshawar on the dates and time as mentioned against each.
- 3. Bid security of 2% as earnest money (where applicable) must accompany with the tender form in the shape of "Deposit at call" in the name of Director General Emergency Rescue Services (Rescue 1122) Peshawar on total amount of the bid neither on one item issued by Schedule Bank of State Bank of Pakistan. If the amount quoted is not for all the specifications/BOQ items, the same will be considered as non-responsive.
- 4. Only technical bids will be opened on date of tender opening in the presence of interested bidders, while financial bids of technically qualified bidders will be opened on a date to be intimated later to qualified firms.
- 5. Earnest money in the form of bank guarantee/cross cheques etc. will not be accepted.
- 6. The procuring entity may reject all bids or proposals at any time prior to the acceptance of a bid or proposal as per the Khyber Pakhtunkhwa Public Procurement of Goods, works and services rules 2014 Rules, sub rule-47(i).
- 7. All Federal & Provincial taxes/ duties i.e. income tax, Sales tax, Stamp duty, disable person rehabilitation tax, or any other tax levied by the Provincial/ Federal Government be deducted.
- 8. The tender documents which are unsigned, unstamped/sealed, incomplete, corrected, tempered, over written will be considered non responsive and will be rejected.
- 9. Affidavit regarding the non-blacklisting of the firm in any part of Pakistan to submitted with application for Bidding Documents (BD) (on Rs.50/- Stamp paper).
- 10. Affidavit regarding 3S Facility verifiable in Peshawar (Khyber Pakhtunkhwa) (on Rs.50/- Stamp paper).
